**NOTES/RULES:**

-Schedule is created at random. Fairness is # 1 priority.

-Game time is forfeit time. If both managers agree, the 5:45 game may have a 10-min. leeway to begin (in the event that a team has a player on their way) but the length of the game will be reduced from 60 min. to 50 min. Each team may borrow ONE player from another team playing in the league (must be on a 2019 Solvang Parks and Recreation softball roster) ONE time during the season to avoid a forfeit. This is not applicable to playoff games. This is a worst case scenario situation to allow teams to PLAY. If a team abuses this rule, the game may result in a loss.

- After a team has used this "borrow," the team without enough players must call 805-688-7529 and opposing team manager no later than 5pm of game day if they need to forfeit again. Hint: Fill your rosters now! You can make changes to your rosters up to the 2<sup>nd</sup> week of play (June 21, 2019).

-Home team will occupy first base dugout.

-Home team is responsible for new game ball. Visiting team is responsible for one good condition "back-up ball".

-Damage to any vehicle, home or other private property is the sole financial responsibility of the player(s) causing the damage.

-Pitching arc is 16'.

-The backstop fence at Sunny Fields extends down the first and third baseline and any ball that passes that "imaginary" line is ruled dead.

-Each team will be allowed unlimited courtesy runners. However, each player can only courtesy run one time per inning.
